All materials will be treated according to the relevant Standards in terms of quality requirements and test conditions.

"Production and tests" tests and controls of parameters such as welding, chemical storage, laminate structure, curing, sealing, gluing, bonding, joining, mold request, wing joining during construction will be provided in line with the standards.

We will fully comply with the laws and contemporary demands in the fields of "Environmental Protection and Occupational Safety." We will create "EFFECTIVE BUSINESS RESULTS" together with all our employees and suppliers by following the principles of "EFFICIENCY AND SAVINGS" that prevent waste of time, cost and resources, and by improving our infrastructure and work environment.
